This supplement (the "Supplement") dated 3 May 2024 constitutes a supplement pursuant to Article 23 (1) of the Regulation (EU) 2017/1129, as amended (the "Prospectus Regulation") and is supplemental to, and should be read in conjunction with, the registration document dated 7 June 2023 (the "Original Registration Document" and together with the Registration Document Supplement No. 1 dated 3 August 2023, the Registration Document Supplement No. 2 dated 3 November 2023, the Registration Document Supplement No. 3 dated 4 March 2024 and the Registration Document Supplement No. 4 dated 4 April 2024, the "Registration Document") of Erste Group Bank AG (the "Issuer" or "Erste Group Bank"). The Registration Document forms part of any base prospectus of the Issuer consisting of separate documents within the meaning of Article 8 (6) of the Prospectus Regulation and as of the date of this Supplement, this Supplement relates to the base prospectuses consisting of separate documents in relation to the following programmes of the Issuer: (i) the capital guaranteed structured notes programme dated 23 June 2023; (ii) the warrants programme dated 7 July 2023; (iii) the debt issuance programme dated 28 August 2023; (iv) the certificates programme dated 25 October 2023; (v) the additional tier 1 notes programme dated 13 November 2023; (vi) the multi issuer EMTN programme dated 4 December 2023; (vii) the structured notes programme dated 7 December 2023; (viii) the covered bonds programme dated 15 December 2023 and (ix) the debt issuance programme dated 18 March 2024.

The Original Registration Document has been approved on 7 June 2023 by the Austrian Financial Market Authority (*Finanzmarktaufsichtsbehörde*, the "**FMA**").

This Supplement has been filed with and approved by the FMA in its capacity as competent authority, filed with the Vienna Stock Exchange (*Wiener Börse*) and published in electronic form on the Issuer's website under "www .erstegroup.com/de/ueber-uns/erste-group-emissionen/prospekte/anleihen/rd07062023".

Terms defined in the Registration Document shall have the same meaning when used in this Supplement.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference in the Registration Document by this Supplement and (b) any other statement in or incorporated by reference in the Registration Document, the statements mentioned in (a) above will prevail.

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to the information included in the Registration Document has arisen or been noted, as the case may be, since the publication of the Registration Document.

In accordance with Article 23 (2) of the Prospectus Regulation, investors who have already agreed to purchase or subscribe for securities issued or to be issued by the Issuer before this Supplement was published have the right, exercisable within two working days after the publication of this Supplement, to withdraw their acceptances until, and including 7 May 2024, provided that the significant new factor, material mistake or material inaccuracy arose or was noted before the closing of the offer period and the delivery of the securities issued or to be issued, whichever occurs first. Investors may contact the relevant financial intermediary if they wish to exercise their right of withdrawal.

The accuracy of the information contained in this Supplement does not fall within the scope of examination by the FMA under the Prospectus Regulation. The FMA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. "Based on the ECB SREP 2023 decision issued in November 2023, the following capital requirements apply to Erste Group as of 1 January 2024:

On a consolidated basis, the additional regulatory capital demands comprise a Pillar 2 requirement of 1.90% (to be held in the form of 56.25% of CET 1 capital and 75% of Tier 1 capital) and a Pillar 2 CET 1 guidance of 1.00%. As a result, the overall consolidated CET 1 requirement of Erste Group is 11.29% as of 31 March 2024 (excluding Pillar 2 CET 1 guidance, but including the capital conservation buffer, the systemic risk buffer, the Other Systemically Important Institutions (O-SII) buffer and the institution specific countercyclical buffer). The CET 1 ratio target is at 14.00%.

On an unconsolidated basis, the additional capital demand is 1.90% Pillar 2 requirement, of which 1.07% has to be covered with CET 1 capital, resulting in an overall individual CET 1 requirement of 10.86% as of 31 March 2024 (excluding Pillar 2 CET 1 guidance, but including capital buffers).

In addition to the CET 1 requirements (consolidated and unconsolidated) described above, overall capital requirements also apply to Erste Group's Tier 1 capital ratio and own funds ratio, resulting in Tier 1 requirements of 13.14% and own funds requirements of 15.62% as of 31 March 2024 on a consolidated basis (and 12.72% Tier 1 capital and 15.20% own funds respectively on an unconsolidated basis). In that context, any shortfall in Pillar 1 and Pillar 2 capital requirement components which could otherwise be made up of AT 1 or Tier 2 capital up to their respective limits would have to be met with CET 1 capital for an AT 1 shortfall and AT 1 or CET 1 capital for a Tier 2 shortfall."
